Purpose of these funds – to support Christian education and youth ministry endeavors of local churches

Criteria & Policy Guidelines

Examples of financial allocations (including but not limited to):

- 1. Christian Education materials and resources (for any or all ages).
- 2. Books and materials that promote faith formation.
- 3. Youth ministry programs that promote personal growth & self-esteem, faith development, community-building, and development of life-skills.
- 4. Confirmation materials and resources.
- 5. Intergenerational programs and projects.
- 6. Support for youth engagement at Association, Conference or National setting events.
- 7. Interfaith studies and engagement

Grant Eligibility

- 1. Member churches of the Covenant Association
- 2. Preference given to first-time applicants
- 3. Grants awarded based on need, merit and funds available at time of application.
- 4. Requested funds must meet approved allocations for use and:
 - a. Must be consistent with the biblical and theological principles and vision of the Covenant Association, Michigan Conference and United Church of Christ
 - b. Requests should be linked with Christian education and/or youth ministry.
 - c. Recipients are expected to provide a written report regarding the impact of funding, by the end of the fiscal year in which the funds are disbursed (Dec. 31).
